## GENERAL INFORMATION

**REVERSE™** is a water-based, silicone emulsion, antifoam and defoamer that can be used to prevent foam formation or knock down existing foam. Use rates for **REVERSE™** depend directly on temperature, composition, viscosity, agitation and other conditions. Therefore, rates may require adjustment for the most effective dosage.

- Reduces mixing time
- Maximizes spray tank capacity
- Safe to add to any tank mix

### **Ideal For:**

- Herbicides and other pesticides known to cause excessive foaming
- Mixtures that include nonionic surfactants
- Application equipment that continuously agitates spray solution

## DIRECTIONS FOR USE NOT FOR AQUATIC USE

**Defoaming:** Squirt it directly on foam that has already formed. Stop agitation then add enough **REVERSE™** to get rid of foam.

**Antifoaming:** Add **REVERSE™** after the first ingredient. Do not add to dry tank or before the addition of water.

Some tank mix partners create more foam than others. For ingredients that cause a lot of foam to form up to 2 ounces per 100 gallons may be required to adequately control foam. Other factors such as temperature and amount of agitation will increase or decrease the amount of control needed.

## STORAGE AND DISPOSAL

**STORAGE:** Store in a cool, dry place. Store in original container only. Do not add anything to the container. Keep container tightly sealed when not in use. Do not store near fire, flame or other potential sources of ignition. Do not contaminate water, food or feed by storage or disposal of this product.

**DISPOSAL:** Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal if allowed by law. The Agricultural Container Recycling Council (ACRC) operates the national recycling program.
